



The Los Angeles Zoo started its 2021-2022 fiscal year off with inspired action by launching its first-ever Conservation Strategic Plan (CSP). On July 22, 2021, Director of Conservation Dr. Jake Owens hosted a live virtual keynote, which featured messages of support from Los Angeles Mayor Eric Garcetti and Councilmember Nithya Raman, outlining the Zoo's historic plan dedicated to wildlife conservation. The CSP aligns with the Zoo's efforts to have a collective impact both here in Los Angeles and around the world by leveraging our knowledge, expertise, partnerships, and engagement with diverse communities to focus on changing the landscape of conservation. As I said then at the launch, Los Angeles is our City—and this is our world. It will take all of us working together to preserve it.

As you'll read in these pages, the Zoo's cornerstone conservation programs saw great progress during the last fiscal year. The advancement of these programs could not be achieved without our members, donors, and guests who come through our gates to support our mission.

Our Learning & Engagement division worked to expand our partnerships with diverse communities, and in autumn 2021, guests had the unique opportunity to participate in the Hispanic tradition of Día de los Muertos with the Zoo's first-ever Beloved Pets Ofrenda. Co-created with the Zoo's Learning & Engagement staff and our partners at Plaza de la Raza Cultural Center for the Arts & Education, the Beloved Pets Ofrenda was designed to honor the memory of cherished animal companions that have passed away. The Zoo will continue to form partnerships within our community to further represent the diverse cultures that make up this beautiful city.

Equity and accessibility continue to be at the forefront of our work. In June 2022, the Zoo launched its first-ever Paid Internship Program to create a sense of belonging to the science, conservation, and zoological fields among diverse communities that have been systemically excluded from these professions. This program provides interns a paid opportunity to work directly with our Zoo professionals on real-world projects and gain valuable work, research, and personal development skills while gaining an empathy for nature. This is the beginning of a long-term plan to meaningfully engage all our communities with even more opportunities.

The Los Angeles Zoo closed out its fiscal year with more than 1.4 million guests visiting their Zoo, which warms my heart to see after the unprecedented pandemic we experienced over the last few years. We cannot discount the fact that the pandemic, outcries for social justice, rising global tensions, and continued efforts to combat the effects of climate change have immensely changed us. I am, however, optimistic that we are on the right path toward a stronger future. If we can take anything away from this past fiscal year, it's this: recovery takes time, but together, we can make it through these challenging moments and build a more resilient future. We will continue to frame our future so that we can all succeed together, and I cannot wait to share updates on our continued progress with you next year.

## From the GLAZA President & Chair

Brian Diamond GLAZA CHAIR In our first year with no attendance restrictions or reservation requirement since the start of the pandemic, the L.A. Zoo is thriving thanks to our wonderful members and donors. By June 2022 we had more than 43,000 membership households—a marvelous rebound from the low of 35,000 that we experienced during the pandemic. All of us at the Greater Los Angeles Zoo Association are deeply grateful for your generosity during this turbulent time.

You mourned with us when our beloved friend and trustee Betty White passed away on the last day of December 2021. In addition to heartfelt notes left at the Zoo's beautiful white rose garden, people from around the world made gifts in Betty's memory. With a generous match from GLAZA trustees, nearly \$250,000 was raised—an incredible tribute to Betty's love for animals and the L.A. Zoo.

We remembered Betty at the Beastly Ball on June 4 by honoring Stephen Badger as the inaugural recipient of the Betty White Conservation Hero Award. The Ball also recognized authors B. Natterson-Horowitz and Kathryn Bowers for their longstanding relationship with the Zoo and their groundbreaking books *Zoobiquity* and *Wildhood*. Honoring Betty made this year's Ball deeply emotional, and we were thrilled that it also raised more than \$1.4 million, the third highest in the event's history.

Our ongoing recovery from the pandemic included full forgiveness of two federal Paycheck Protection Program (PPP) loans, a total of \$2 million that made a huge difference for us over the last two years. The State of California made its very first allocation to GLAZA and the Zoo, \$2.21 million for four capital projects: a Cape vulture habitat, swan pond, inclusive restroom design study, and the Angela Collier Garden event space. Many thanks to our dear friend Senator Anthony Portantino who made this allocation possible! The generosity of foundations, corporations, and individual philanthropists was also exceptional this year, including a \$1 million gift from an anonymous donor for the Zoo's Conservation Strategic Plan.

This Spring, we launched the Conservation Council for emerging leaders passionate about wildlife and nature. Our volunteer program grew with the inauguration of the Specialty Docent Program, an innovative way for people who work during the week to share their interpretive skills with Zoo visitors on weekends. The engagement of our wonderful staff, trustees, donors, and volunteers underscores the idea that zoos are inhabited by both animals and people, and the humans in our Zoo family are truly amazing.

These exciting developments not only demonstrate our resilience but also point toward the realization of our Vision Plan, the exciting road map for the future of the Zoo that made considerable progress this year. We look forward to celebrating the future of the Zoo with you!

## Remembering Betty White

etty White passed away on December 31, 2021, just weeks shy of her 100th birthday. Betty's involvement with the Los Angeles Zoo stretched back more than five decades. A lifelong animal lover, she was a longtime GLAZA trustee and donor, Zoo Commissioner, the City of Los Angeles' Ambassador to the Animals, and an honorary zookeeper. Betty often quipped that she had to stay in show business to pay for her animal business—and she wouldn't have it any other way. Throughout her busy Hollywood career, she remained a steady presence at the Zoo, working behind the scenes to raise funds for new habitats for the animals. She was a vocal advocate for animals and the people who care for them—and an early champion of conservation. This Annual Report is dedicated to her memory.

# 2021-2022 FISCAL YEAR IN REVIEW

## Family Nature Club

he Zoo's Learning and Engagement Division initiated a new partnership with the City's Recreation and Parks Department to bring free nature play programming to Griffith Park. The team facilitated nine events from October to June, engaging 344 community members in outdoor play and exploration.









## Earthly Enrichment

he LGBTQIA+ volunteer network Gay for Good mobilized a team of volunteers to help the Zoo celebrate Earth Day in 2022. The team of 26 decorated dozens of globes and boxes to be given to our animals as enrichment. Novel enrichment items provide mental and physical challenges, encouraging animals to explore and interact with their environment.



## OUTWARD BOUND

The Zoo began partnering with Outward Bound Adventures (OBA) in Fall 2021. OBA is dedicated to providing access to nature and environmental education for low-income, gang-impacted, and historically excluded adults and youth.



## SUPER TROOPERS

The Zoo's chimpanzee troop expanded with the arrival of two males in early 2022. Eight-year-old Mshindi (above) and 22-year-old Pu'iwa have been slowly integrated into the group, which is managed in a fission-fusion fashion in which chimps can separate into subgroups and have a choice of who they spend time with during the day. This mirrors the species' behavior in the wild.

## SLOW AND STEADY

he newest member of our giraffe herd was a newsmaker from day one. At 6'7", the baby boy was the tallest calf ever born at the Zoo. Keepers helped keep the calf calm as veterinarians performed the post-birth examination. This vital first check-up is standard procedure for all zoo births, big and small.

Preventive care is key to ensuring that every animal at the Zoo thrives. In addition to closely monitoring our animals for any sign of illness, the Gottlieb Animal Health & Conservation Center staff routinely perform physical examinations, run diagnostic tests, and administer vaccines. Thanks to portable diagnostic equipment and training protocols, these exams are more likely than not conducted while the animal is awake and in its habitat. In the last fiscal year, we entered 7,741 medical notes for our animals, and only 152 of those represent anesthetized exams. We collected 2,635 diagnostic samples, of which 1,451 were fecal samples and 447 were complete blood cell counts (CBCs). Fecals represent a big part of our wellness program as they are an easy, non-invasive diagnostic test.

The Zoo's Medical Advisory Board (MAB), composed of 68 members from a broad range of medical specialties, continues to consult on special cases. This support is critical to improved patient outcomes as it leverages the varied professional expertise of its members. These collaborations also provide invaluable opportunities for growth and information-sharing across disciplines. We are grateful to these extraordinary individuals for lending their time and talents to the Zoo.





## **COMMITMENT TO CONSERVATION**

Endangered species around the globe are benefiting from conservation grants or field assistance provided by the Los Angeles Zoo in Fiscal Year 2021–22. The programs we support engage in a variety of conservation activities, including studying wild populations, creating sustainable breeding programs, reducing habitat destruction, strengthening community engagement, and promoting peaceful coexistence between people and wildlife. In these pages, we spotlight some of these programs and the impact that we've made, thanks to the support of our generous members, donors, and friends.



## CONSERVATION STRATEGIC PLAN

e launched our groundbreaking Conservation Strategic Plan (CSP) in July 2021. The planthe first in the L.A. Zoo's history solely dedicated to wildlife conservation-identified six focal areas where we will prioritize our growth and impact: California conservation, social and environmental justice, illegal wildlife trade, human-wildlife coexistence, conservation translocation, and evidence-based conservation. In this first year of implementation, we've made great strides in advancing our goals, particularly in the areas of California conservation and social and environmental justice.

## Pronghorn Preservation

n November 2021, L.A. Zoo staff traveled to Baja California, Mexico, to participate in the first-ever release of collared peninsular pronghorn to the wild. Eight captive-reared pronghorn were fitted with GPS tracking collars, then released. Zoo staff also helped develop interpretive graphics for the Peninsular Pronghorn Visitor Center near the reserve.





## Conservation Committee

The Zoo's Conservation Committee furthered its work to engage with local communities and strengthen staff and volunteer involvement in our mission. They hosted several events, including maintenance and monitoring of the Bette Davis micro-forest project in Griffith Park, nature outings, and habitat restoration and cleanups.



Through a generous donation from the L.A. Zoo-and with their team's expertise and effort—it has been possible to create a magnificent exhibition in which the peninsular pronghorn is not only the protagonist but also the link to the area's natural, cultural, and regional values.

## Mountain Frog Recovery

n August 2021, the Southern Mountain Yellow-Legged Frog Recovery Program transferred 150 L.A. Zoo-hatched tadpoles and 125 wild tadpoles received from UCLA to the Aquarium of the Pacific to headstart as a cohort for an eventual release. In September 2021, 504 tadpoles from the L.A. Zoo were released into their native habitat in the San Gabriel Mountains.

## Komodo Dragons

he mission of the Komodo Survival Program (KSP) is to protect and manage populations of the Komodo dragon. In collaboration with Komodo National Park, the KSP conducts large-scale Komodo dragon population monitoring in eastern Indonesia. The long-term objective of the program is to ensure that this national park remains a protected habitat for Komodo dragons.

"For more than a decade, the Los Angeles Zoo has generously supported the Komodo Survival Program. L.A. Zoo funding has been used to conduct several activities including surveys used to count the annual number of breeding females and observe their nesting activities using camera traps. This research is essential to estimate the size of the annual nesting population and also the potential number of Komodo dragon hatchlings that will enter the population. This knowledge helps contribute to informed decisions regarding the management and conservation of this endangered species."

## Blue-Throated Macaws

he blue-throated macaw is critically endangered due to habitat loss and the illegal pet trade. The L.A. Zoo has successfully bred this rare bird in its Avian Conservation Center and contributes to its conservation in the field. The Bird Endowment's Nido Adoptivo Nest Box Project raises funds to install artificial nest boxes in the Laney Rickman Reserve in Bolivia to increase nest site availability. Since 2018, the Zoo has sponsored the installation of 20 artificial nest boxes in key nesting areas, resulting in seven blue-throated macaw chicks fledging in the wild.

"Bird Endowment and our partner Asociación Armonía are truly grateful for the generous support of the Los Angeles Zoo in saving the blue-throated macaw from extinction. When this project started 15 years ago, only 100 to 150 remained in the wild. Today, its numbers have increased significantly. Today, there are 400 to 450—an incredible 113 having fledged from our nest boxes. Thanks to support from the Los Angeles Zoo, the blue-throated macaw is flying toward a brighter future!"

he largest eagle in the Americas, the harpy eagle is declining rapidly in certain portions of its range due to deforestation and human persecution. Since 2007, the L.A. Zoo has supported the Peregrine Fund's efforts to monitor and preserve harpy eagle populations and increase local resilience through science, education, and community engagement.

"With the generous and steady support of the Los Angeles Zoo, the Peregrine Fund is protecting the largest harpy eagle population in Central America, located in the Darien-Choco Region of Panama within one of the most biodiverse rainforests on the planet. Specifically, during 2022, the L.A. Zoo contributed to (1) developing the capacity of 30 indigenous Emberá and Wounaan people in agroforestry and forest restoration techniques, (2) conducting 184 field patrol and vigilance trips to monitor 46 pairs of harpy eagles and their nesting areas, assuring their survival and protection, (3) training 50 indigenous people as mentors for conservation, and (4) reaching more than 10,950 people with our environmental education campaigns."

## Gorillas

he L.A. Zoo has partnered with the Gorilla Rehabilitation and Conservation Education (GRACE) Center since 2015. GRACE's mission is to provide rehabilitative care for rescued Grauer's gorillas and to work alongside communities in eastern Democratic Republic of the Congo (DRC) to promote appreciation and conservation of wild gorillas and their habitat.

"A gorilla-sized thank you to L.A. Zoo! Your impact was really felt in 2022. First, youth members of GRACE's Conservation Clubs and the L.A. Zoo's Zoo Pals program connected across continents. They learned about gorillas and participated in a meaningful cross-cultural exchange.

Second, L.A. Zoo provided funding for a new radio campaign. Written and produced by GRACE Educators, the campaign highlighted the connection between healthy forests, healthy gorillas, and healthy communities. More than 15,000 people learned about Congo forests because of your support.

Third, L.A. Zoo made it possible for GRACE educators to expand their outreach into a new village this year. In partnership with a community association, they built a sustainable woodlot to provide an alternative to cutting trees from the forest for household use. This benefits people and protects gorilla habitat."

## Painted Dogs

ainted dogs are one of the most endangered mammals in Africa, with poaching and habitat fragmentation the greatest threats to their survival. The Painted Dog Research Trust works to protect and expand the population of painted dogs in Zimbabwe. The L.A. Zoo has been supporting this vital work since 2018, funding extensive wild-life surveys, anti-snare tracking collars, and camera traps to monitor the movements and behaviors of painted dogs. As a result of these efforts, the species has bounced back from a population of less than 200 to more than 700 individuals.

"Over the years, the L.A. Zoo's support has been not only consistent but made a huge difference, and so embodies our motto 'Your Support Is Their Survival.' Such long-term conservation partnerships make all the difference from the point of long-term planning. The latter was particularly salient as we all struggled through COVID yet managed to keep not only all of our staff but also packs of painted dogs alive ... Teamwork at its best!"

## Saola & Muntjac

or several years, the Los Angeles Zoo has supported efforts to safeguard two of the rarest mammals on Earth: the saola and the large-antlered muntjac. Found only in the Annamite Mountains bordering Vietnam and Laos, both species are in desperate need of conservation intervention. With funding from the L.A. Zoo, Re:Wild is conducting extensive wildlife surveys in central Vietnam's Truong Son forest—the first ever performed using modern field methods.

"The preliminary findings from the interview and camera-trapping surveys in the Truong Son forest area are encouraging. Clearly, this area is an important stronghold for many rare and endemic species, and we believe it is possible that large-antlered muntjac and saola still occur there (though, if they do, their numbers are critically low). Without support from the Los Angeles Zoo, we would never have been able to conduct this project. We are especially grateful to the Zoo for supporting conservation work for two species that are not held anywhere in captivity. What an amazing example of how zoos can give back to conservation everywhere."

## Gharials

ith an estimated 650 adult individuals remaining in the wild, the Indian gharial is classified as critically endangered. The L.A. Zoo has provided multi-year support to the Gharial Ecology Project (GEP) of the Madras Crocodile Bank Trust, which monitors and conserves gharials in the Chambal River, one of the most pristine and undeveloped watersheds remaining in India. Recent L.A. Zoo funding enabled the GEP to purchase tracking radios and deploy satellite tags on gharials to collect data on their movements and activity patterns—information that will be vital to informing future management strategies and conservation actions for the species.



## **Tapirs**

he Baird's tapir is one of the most ecologically important species in Central America. By dispersing seeds, they regenerate tropical forests and play a key role in fighting climate change. With fewer than 4,500 adult Baird's tapirs estimated to remain in the wild, the L.A. Zoo is proud to support the Costa Rica Wildlife Foundation (CRWF)'s efforts to conserve this iconic endangered species. With the support of the Zoo and other partners, CRWF engages farmers, tourism operators, community members, and local authorities in a collaborative program to reduce human-tapir conflict and improve economic stability in the area.






