## **AGENDA ITEM 6**

#### PRESENTATION - 2022/23 APPROVED CITY BUDGET

Deputy Director Mei Kwan, provided an overview of the Zoo's approved City budget for FY 23.

- Budget requests are due November of prior fiscal year (November 2021)
- Budget requests were based on some COVID-19 assumptions related to operations
- Attendance history review; project 1.5 million visitors in FY 23
- Revenue history review; project \$15 million in FY 23
- Total operating budget approved for the Zoo is \$27.7 million represents an 11% increase from prior FY
- · Discussed source of funding
- Provided budget goal for this fiscal year

Commissioner Hopkins asked if the Zoo was contemplating a ticket price increase based on current inflation. Deputy Director Kwan explained that ticketing pricing is reviewed every year, but this year no increase was considered based on equitable access to the Zoo. Vice President Silva asked if we've surveyed other institutions to review operations and ticket costs. President Winnick asked to review the latest comparisons with other facilities. Director Verret noted she will provide the Commission with the last comparison completed.

## AGENDA ITEM 7

#### **GENERAL MANAGER REPORTS**

### A. Animal Updates

Beth Schaefer, General Curator, gave the following transaction updates:

- Outgoing bat-eared fox as SSP recommendation
- Santa Ana Zoo is now involved in the mountain yellow-legged frog breeding and release program
- Invertebrates added to LAIR
- Archerfish hatchlings
- Roti island snake necked turtles have bred and hatchlings will be translocated back to the wild

### B. GLAZA Update

GLAZA President Tom Jacobson gave the following update:

- Achieved 161% (\$2.4 million) of total restricted fundraising goal for the year
- Membership is over 44,000 households

- Attendance and revenue continue to be well ahead of projections
- GLAZA received \$2 million from the State in this year's budget
- President Jacobson noted he will have final FY 22 numbers at the August meeting
- GLAZA will be hosting Zoo Lights this winter

## C. Zoo Director Update

Zoo Director Denise Verret provided the following updates:

- Six weeks into the paid internship program
- Zoo Camp is in week five and continues to be well attended
- In connection with Recreation and Parks, the Zoo's Learning & Engagement staff will be visiting 36 camp sites throughout the City bringing the Zoo to you.
  - The Zoo submitted the EIR for the Vision Plan to City Council in July 2021. Since then, the Zoo has received over 300 comments related to the EIR/Vision Plan. Zoo staff met with stakeholders and reviewed public comment. After much consideration, the Zoo has developed Alternative 1.5 California Focused Alternative. Director Verret noted this is the environmentally superior alternative. Alternative 1.5 removed the parking structure, aerial tram, and increased protection for current flora and fauna. Public comment began on July 14 and will end on August 29 with a virtual public meeting being held in August. Director Verret is hopeful this new plan will go before Council in the fall.

President Winnick asked to include the EIR/Vision Plan to the next agenda for further discussion and take possible action.

Vice President Silva asked how GLAZA's Friday Nights are going. GLAZA President Jacobson noted there was an attendance increase between the first and second nights and they anticipate more attendance as word of mouth gets out.
